

## **PREFACE**

The ABO exists to provide advice, support, intelligence and information to the people who make British orchestras a global success. Focusing on its three key objectives, Connecting, Championing and Developing – for both the UK's professional and youth orchestral sectors – the association presented a diverse and comprehensive programme of work throughout 2017/18.

The annual ABO Conference took place in Cardiff with the main theme being collaboration, along with an additional focus on inclusion and diversity. With three host organisations working closely together to present the three-day event – Welsh National Opera, BBC National Orchestra of Wales and Sinfonia Cymru – near record delegate numbers and an extensive range of thought-provoking sessions, the conference once again proved to be a vitally important and highly relevant meeting place for UK orchestras and increasingly, those from abroad.

2018 is the 70th anniversary of the ABO. To mark the occasion a special Parliamentary Reception was held at the Palace of Westminster in March. It was a welcome opportunity not only to celebrate the remarkable achievements of the ABO and its members over many years, but also to restate the value, importance and relevance of the UK's orchestral sector today.

The ABO is committed to supporting the development of the people who work within the orchestral world. Amongst other initiatives, its leadership programme Find Your Way – now in its third full year – is proving to be a highly effective means of nurturing the talent that exists within our sector. The ABO looks forward to the development of this important work in the coming years.

The ABO is also committed to the health and wellbeing of everyone who works in the orchestral sector in the UK. Engagement with issues such as Noise at Work regulations and Dignity at Work have been and will continue to be important areas of focus.


Following the result of the EU Referendum in 2016, the potential implications of Brexit for our members continued to be a cause for concern throughout the year. The ABO's engagement with Government, and in particular the Migration Advisory Committee, aims to ensure that the most significant areas of concern for our members are being heard and considered at the highest levels.

The AGM in November 2017 saw several changes to the Board including the Chair. The ABO acknowledges the service and commitment of those individuals who retired from the Board at this time – including Kathryn McDowell on completion of her term as Chair.

The Board also acknowledges the significant support it receives on an ongoing basis from the management team, led by Director Mark Pemberton, which delivers the ABO's annual programme of work so effectively.



## INTRODUCTION

2017/18 saw the ABO continue to deliver on its key objectives of connecting, championing and developing professional and youth orchestras across the UK.

We were delighted to hear positive reports from members of the successful implementation of Orchestra Tax Relief, providing an alternative and welcome source of funding for our members at a time of continued pressure on public investment for the arts, both at national and local level.

Less positively, we spent much of the year consulting members on the potential impact of Brexit on the orchestral sector. The ABO has continued to play an active role in liaising with the DCMS and the Migration Advisory Committee on achieving a positive outcome for our sector.

Other priorities during the year saw us continue to support the Family Arts Campaign, and we are encouraged by the continued engagement with the campaign by our members. We continued to work in partnership with the PRS Foundation on the Resonate programme, and launched Sirens, following receipt of a donation from Diana Ambache to the ABO Trust, which provides grants to programme works by historical women composers.

In line with our focus on leadership, the ABO ran its Find Your Way programme for a third year, supported by the ABO Trust with additional funding from Arts Council England and the Jerwood Charitable Foundation.

Once again we held a very successful conference, with attendance exceeding expectations, seeing delegates drawn from across the globe. We are hugely grateful to our hosts, the BBC National Orchestra of Wales, Sinfonia Cymru and Welsh National Opera, and our gratitude as ever goes to our principal media partner Classic FM, and to BBC Radio 3 for helping us celebrate 40 years of BBC Young Musician during the closing session, and to the many other sponsors and partners who helped make the conference such a success.

The year culminated in a Parliamentary Reception to celebrate our 70th anniversary, attended by the Minister for Arts, Heritage and Tourism and the Shadow Secretary of State for Culture, Media and Sport.

We are grateful for the active support of board members during the year. As ever, we remain committed to delivering

on our mission of connecting, championing and developing professional orchestras and youth ensembles across the UK, and to ensuring a vibrant and sustainable sector.

## REVIEW OF THE YEAR 2017/18

To be presented at the Annual General Meeting of the Association of British Orchestras

### MISSION AND OBJECTIVES

The ABO board agreed the following **mission statement** on 19 April 2016: The ABO's mission is to enable and support an innovative, collaborative and sustainable orchestral sector. It exists to provide advice, support, intelligence and information to the people who make British orchestras a global success.

The key objectives of the Association cover three areas of activity:

- Connecting
- Championing
- Developing

Using the framework of the mission statement, our key **aspirations** for 2016-2019 will be to deliver on these key objectives through:

- **Connecting** members to other members and the wider industry through networking opportunities, keeping our members well-informed and up-to-date with best practice to help build resilience and financial sustainability.
- **Championing** British orchestras and the wider membership, raising their profile and influence with key stakeholders and the British public, through political engagement, the media, social media and stakeholder bulletins. We will track and influence the development of cultural policy from the European Union, UK government, local government and devolved administrations, and advocate the value of public and private investment in the orchestral sector.
- **Developing** the skills and knowledge of our members' staff, including providing and signposting to high quality professional development opportunities for all tiers of management and musicians and nurturing emerging leaders.

We will apply the same key objectives to our **youth ensemble** membership:

- **Connecting** the youth ensemble membership with each other and with the professional sector, keeping them well-informed and up-to-date with best practice to help build resilience and sustainability.
- **Championing** youth ensembles, raising their profile and influence with key stakeholders and the British public, through political engagement, the media, social media and stakeholder bulletins. We will track and influence the development of cultural policy and advocate the value of support for youth ensembles through local music education bodies and private investment.
- **Developing** the skills and knowledge of those who work for or volunteer their time to support their local youth ensemble.

# CONNECTING

#### **ABO** Conference

This year's Conference, in association with our Principal Media Partner Classic FM, took place from 24-26 January 2018, hosted by the BBC National Orchestra of Wales, Sinfonia Cymru and Welsh National Opera.

The Conference theme was **Collaboration**, with an additional focus on diversity and inclusion. Sessions were held in partnership with the ISM, BBC Radio 3, Classic FM, London Music Masters, Creative Europe Desk UK and the British Council.

The closing session saw Alan Davey CBE, Controller BBC Radio 3, BBC Proms, BBC Orchestras and Choirs, announce the BBC's plans for classical music, followed by a celebration of 40 years of BBC Young Musician with performances by 2014 winner Martin James Bartlett and 2016 Finalist and Woodwind Category winner Jess Gillam. The conference closed with the launch of the ABO's 70th anniversary, before an invitation to delegates to attend the 2019 Conference in Belfast.

Our hosts presented two concerts – BBC National Orchestra of Wales and Welsh National Opera performed in Hoddinott Hall for a joint concert on the evening of Wednesday 24 January, and Sinfonia Cymru gave a performance of *Birdsong* in the Weston Studio on the afternoon of Thursday 25 January.

Sponsors of the conference included Rhinegold Publishing, British Association of Concert Halls, Incorporated Society of Musicians, British Council and BBC Radio 3, and we are grateful to the Musicians' Union for providing financial support for attendance by musicians.

Headline numbers for the conference are that in 3 days we:

- put on 24 different sessions (including 2 breakfast events)
- with 100 speakers / panellists
- to 385 total unique delegates
- seated 245 at the awards dinner
- and sold 125 tickets for the BBCNOW/WNO concert

### Specialist Managers Meetings

Specialist Managers Meetings continued to form the backbone of the ABO's events programme. Meetings for Archivists, Chairs & Trustees, Chamber Orchestras, Concert & Orchestra, Communications, Digital, Education, Fundraising, Finance, Opera & Ballet and Stage & Transport Managers, along with Scottish and Welsh members took place during the year, with 473 attendees in total. We also held a Summit on the impending General Data Protection Regulation at Kings Place.

The Specialist Managers Meetings provide opportunities for colleagues from different organisations to meet and discuss subjects of mutual interest and benefit from the latest developments in their field through talks and surgeries given by experts. Reports of the meetings are available to download from the members' area of the ABO website.

### Website, Social Media and Update

The ABO's website continued to be an invaluable source of communication and information for members and the general public. Figures show that there were 73,418 visits from 22,506 unique visitors generating over 153,320 page views. These are an excellent measurement of how valuable the website has become in communicating its message to members and the wider world.

The ABO has continued to "tweet" relevant news via Twitter to over 7000 followers and the hashtag for the ABO Conference was widely used by delegates as well as observers away from the conference.

The ABO continued to distribute its much-valued monthly e-bulletin, and Education and Youth Ensemble e-bulletins, to members.

# **CHAMPIONING**

#### **Public Affairs**

The ABO team met regularly during the year with representatives from the government and funding agencies, and holds regular meetings with the UK's arts associations and entertainment unions to discuss common strategies on arts policy and funding.

In April 2017 the ABO appointed Connect Communications to serve as Public Affairs consultants. Their role is to provide strategic advice, monitoring and research as well as help with the production of key documents – such as letters to Government ministers and submissions to the political parties' manifestoes for the 2017 General Election. They also arranged meetings between the ABO and relevant parliamentarians and officials.

Over the past year, meetings were held with officials at DCMS, Migration Advisory Committee, clerks of the Brexit Select Committee and with MPs to present evidence on the impact of Brexit on the orchestral sector. A meeting with the Minister for Arts, Heritage and Tourism took place in March 2017.

On 7 December 2017, a debate took place in the House of Lords on youth orchestras. This was a result of the ABO presenting to the Liberal Democrat Digital, Culture, Media and Sport Committee, with Baroness Bonham-Carter taking forward the points raised in order to secure the debate. Connect worked with the ABO to promote the debate to relevant Peers and produced a template email for ABO members to use to ask Peers that they have relationships with to attend and speak in the debate. Following the debate, we helped to draft a response to Lord Ashton of Hyde, to respond to various incorrect points he made during his speech. This has resulted in two clarifying letters being issued by the Department, with the Director being invited in for a meeting to discuss the issues further.

The ABO and Connect have also worked together to secure the tabling of several Parliamentary Questions, for example from Stephen Timms MP (Lab, East Ham) and Sammy Wilson MP (DUP, East Antrin), who are both members of the Brexit Select Committee. Connect has also been working with Stephen Timms to table a Westminster Hall debate on the UK orchestral sector including proving a briefing on key ABO issues.

Our e-bulletin, ABO News, with news and information on the activity of ABO members, was sent to parliamentarians and key stakeholders at regular points during the year.

#### Communications

Over the last twelve months Claire Willis of ElevenTenths PR has supported the ABO team, providing media relations and public relations support across all its activities. This included the first round of Sirens Awards in June 2017 – placing coverage in specialist media outlets – and announcing Find Your Way applications in August 2017, with a main press release October 2017 coordinated with the Jerwood Charitable Foundation.

For the ABO Conference in Cardiff, Claire met with host PR & Marketing teams to establish key messages and coordination of activity, supported the ABO team in commissioning editorial for the conference edition of Classical Music magazine (featuring the Director as guest editor), providing social media support including live-tweeting at the awards, coordinating photography and sending out information overnight.

Following the AGM in November a press release was coordinated with the SCO to announce Gavin Reid's election as the new ABO Chair. The appointment was announced in outlets including Ed Vaizey's newsletter, music titles, Arts Professional and Slipped Disc.

Claire accompanied the Chair to the concert where he presented Marin Alsop with the ABO Award, and coordinated photography for distribution to specialist outlets.

For the ABO Parliamentary reception in 2018, Claire coordinated invitations to media, and David Wooding of the Sun on Sunday attended along with editors of specialist publications. Claire chaperoned the parliamentary photographer to ensure key music people were pictured with politicians, and drafted and distributed the press release with approved quotes from Michael Ellis MP,Tom Watson MP and Harriet Harman MP with the images the following day.

### All-Party Parliamentary Classical Music Group

The Group's purpose is to bring together parliamentarians who have an interest in and wish to further the appreciation of classical music; to act as an interface between British orchestras' on and off-stage activities, the wider classical music industry, including broadcasters and the recording industry, and key decision makers and opinion formers; and to look at the potential for establishing parliamentary classical music awards and promoting and supporting young musicians. The ABO serves as the Group's secretariat, and advised parliamentarians during year on various issues.

Meetings took place in July featuring Anthony Bowne, Principal of Trinity Laban Conservatoire; and in November with Lincoln Abbotts, Executive Director, Strategic Development, ABRSM, and Sam Jackson, Managing Editor, Classic FM, who updated parliamentarians on The Music Commission.

### **ABO 70th Anniversary**

In March a Parliamentary Reception was held to celebrate the ABO's 70th anniversary, featuring speeches from Michael Ellis MP, Minister for Arts, Heritage and Tourism, Tom Watson MP, Shadow Secretary of State for Culture, Media and Sport, Barbara Keeley MP, chair of the All Party Parliamentary Group on Classical Music, and Harriet Harman MP. There was a musical performance by students from Trinity Laban Conservatoire for Music and Dance. Classic FM sponsored the event, and presenter John Suchet was Master of Ceremonies for the evening. A special website was launched at the reception with a timeline of achievements by the ABO and its members over the past 70 years, as well as information on British orchestras today. ### ABO/MU Casual Concert/Freelance Orchestral Agreement

The ABO continued to meet regularly with the MU through its working party comprised of Mark Pemberton, ABO, John Harte, Aurora Orchestra, Elaine Baines, City of London Sinfonia, Timothy Walker, London Philharmonic Orchestra, James Williams, Royal Philharmonic Orchestra, and Peter Helps, Sinfonia Viva, ensuring that an agreement was in place for 2017/18.

A **Special Award** was presented at the conference dinner to **John Smith**, former General Secretary of the Musicians' Union.

**ABO/Rhinegold Awards** were presented by Anne-Marie Minhall, Classic FM presenter, to **Sue Mallet**, Director of Planning, London Symphony Orchestra (Orchestra Manager of the Year), **Richard Heason**, Director, St John's Smith Square (Concert Hall Manager of the Year) and **Bettina Mehne** and **Bernhard Kerres**, Hello Stage (Artist Manager of the Year).

#### National Music Council and Music Education Council

The ABO is a member of the National Music Council, which exists to promote the interests of the music sector. The Director was re-elected as the NMC's Chairman in December 2017. It is also a member of the Music Education Council and was elected to the MEC Forum in May 2017.

### Pearle\* and International Engagement

The ABO and its members benefit hugely from membership of Pearle\* (Live Performance Europe), the European league of performing arts associations, which helps the ABO keep track of and influence legislative and regulatory developments within the EU and which holds twice-yearly conferences of its members. The Director attended its conferences in Copenhagen in June and Madrid in November. He also attended meetings of the Live Performance Sector Social Dialogue Committee in Brussels, which bring together employers' associations and trade unions from across the EU.

The ABO benefits from attending international conferences and engaging with colleagues abroad, through forging connections with arts leaders, orchestras and orchestral associations in other countries, and sharing and disseminating best practice to our respective memberships. These included Classical Next in Rotterdam in May, where the Director cochaired two sessions for orchestral delegates; the League of American Orchestras in Detroit in June, where the ABO's Education & Youth Ensembles Consultant attended Education and Community Engagement constituency meetings; MIDEM in Cannes and the Nordic Theatres & Orchestras Association conference in Oslo, both in June, where the Director gave speeches on Brexit; and the International Orchestras Conference in Cascais, also in June.

## **DEVELOPING**

The ABO continues to provide access to a range of briefing sheets on topics of relevance and concern to the membership, and provides up-to-date information on events and information via its monthly email Update for members. The ABO continued to offer advice for the benefit of its members, and we are grateful for the pro-bono advice on VAT provided by Graham Elliott and tax advice from Smith & Williamson.

### Family Arts Campaign



The ABO remains a member of the Family Arts Campaign consortium and is represented on the Project Board. The Campaign has now moved into a four year period as an Arts Council England Sector Support Organisation, with The Albany as accountable body. New projects include Family Arts Campaign webinars and plans to widen access to data on family audiences through a partnership with The Audience Agency's Audience Finder database.

Work on core activity will continue, including promotion of family events via the Fantastic for Families listings website, training including the biennial Family Arts

Conference, support to local Family Arts Network, and promotion of the Family Arts Standards quality-mark.

Work on promoting age-friendly and intergenerational practices will continue through promotion of the new Age-Friendly Standards and biannual Celebrating Age sharing seminars. Local Family Arts Networks have recently completed collaborative Age-Friendly projects funded by ACE Grants for the Arts, applied for by the ABO on behalf of the Campaign. Evaluations of these projects are now being collated into a resource to share learning with the sector.

### Professional Development

There were **106** attendees for the ABO's training courses, with attendees very positive about the content and insight gained. ABO courses included Fundraising, HR for non-HR Managers, Marketing, and Working with Creative People, while ABO members also attended a range of UK Theatre courses.

### Leadership Programme: Find Your Way (FYW)

The previous year's programme finished with a final group meeting in July 2017 where participants head from John Summers, Hallé, Tim Walker, LPO and the ABO Director. Over the summer the ABO put out an open call for applications to the 2017/18 programme and, following phone interviews, selected six participants. The programme in 2017/18 was jointly run by Richard Wigley, Wigley Arts Management and leadership trainer Andy Beaumont, to help Richard Wigley to allocate his time alongside his CEO role at Ulster Orchestra. Richard and the Education & Youth Ensembles Consultant matched participants with mentors. In 2017/18, the ABO attracted funding from Arts Council England and the Jerwood Charitable Foundation, in addition to funding from the ABO Trust.

The 2017 group's first meeting took place in October, led by Richard Wigley and Andy Beaumont, and included a FYW alumna, Jenny Chadwick of the CSBO.A second meeting took place in November, when the group met with mentors on the pilot programme, Sophie Lewis, Sinfonia Cymru and Dougie Scarfe, Bournemouth Symphony Orchestra. Richard held one-to-one meetings with the participants in late November/early December.A third group meeting took place at the Sage Gateshead, when the group met with Abigail Pogson, Managing Director, and Clarence Adoo, Orchestral and Health Programme Leader, Sage Gateshead. The cohort ran a session at the ABO Conference in January, using the 'Collaboration' theme, titled 'Us vs Everyone', looking at audiences, branding, funding, customer loyalty and co-investment.

Following a successful pilot residential course in 2016/17, the residential course once again took place at Snape Maltings from 16-18 March. Led by Richard Wigley and Andy Beaumont, it included the participation of Roger Wright, Sarah Gee (Marketing), Anna Rowe (Finance), Mark Pemberton (ABO), Claire Wrathall (writer and editor) and the Education & Youth Ensembles Consultant. The course

was opened to six additional participants through a selection process. Places were also made available to non-UK orchestras through Pearle. The additional 6 participants were:

The first half of the course included coaching, subject specific information on finance, marketing, fundraising and artistic planning; the second half included a presentation to a Board, a session on delivering difficult messages, and coaching on giving feedback and mentoring.

### Healthy Orchestra

The ABO maintained its Healthy Orchestra programme. The ABO is a partner in Conservatoires UK's Musical Impact project, which over four years will work to enhance the health and wellbeing of musicians studying and working in Britain.

#### Sirens

The Sirens fund has been made possible by a generous gift from Diana Ambache to the ABO Trust, aiming to raise awareness and appreciation of the music written by historical women from around the world. The fund has an annual end of February deadline. In 2017, three awards were made to:

## EDUCATION & YOUTH ENSEMBLES

Over the year the ABO worked hard to ensure that orchestras were kept up to date on developments in music education, including Music Education Hubs, safeguarding, child performance licensing, diversity and inclusion, the Music Commission (looking at music progression) and Government consultations.

The ABO continued to work with the Music Education Council (MEC), Music for Youth, Music Mark and Making Music to pressurise the Department for Education to effect changes in the law on Child Performance Licensing. The ABO continued to support the #baccforthefuture campaign.

The Education & Youth Ensembles Consultant represented the ABO on the BBC Ten Pieces Stakeholders group, and attended the League of American Orchestras Conference in Detroit in June (using the ABO's reciprocal arrangement for a conference place). The theme of the Conference was 'Detroit Rising – Transformation in American Orchestras'. The American Orchestras' Education and Community Engagement Directors held their own programme of sessions as part of the main Conference, focusing on many aspects of partnership including partnering for change, with the community, and with development departments.

The bi-annual Specialist Manager Meetings of education managers continue to enable members to share their work, including guest speakers who represent participants in orchestral education projects, or those who work with the participants such as teachers.

In April 2017 the morning's agenda included ABO updates on youth ensembles, child performance licensing, EBacc, Music Education Council, with brief updates from Sarah Derbyshire, Orchestras Live and Ellara Wakely, BBC, on Ten Pieces Year Two. The afternoon focused on extending partnerships through technology with guests and presentations from Barry Farrimond, OpenUp Music; Bill Chandler and Samantha Wright, RSNO; Steve Pickett, Hallé and Peter Green, University of Manchester.

In October 2017 the morning featured updates on Child Performance Licensing, Safeguarding, Music Education Council, EBacc, Youth Ensembles, and the Family Arts Campaign, and BBC Ten Pieces Year 2. Professor Adam Ockelford, Roehampton University, composer, performer, teacher and researcher, joined the meeting to talk about autism and music, and working with young people with special needs. The afternoon focused on 'relaxed' performances with presentations from Stuart Bruce, Orchestras Live and Ellara Wakely, BBC Proms.

The ABO has since set up a music and health working group to discuss and share work, and to develop a shared strategy with the ABO about advocating collectively for this important side of orchestras and concert halls' work.

#### Youth Ensembles

The ABO's offer to its youth ensemble membership included opportunities to meet during the Annual Conference and a tailored E-Bulletin.

Following the second Youth Ensembles event in Birmingham (March 2017), we continued to work in partnership with Music Mark by holding sessions for and with youth ensembles at our respective conferences. In November 2017, the Education & Youth Ensembles Consultant chaired the Music Mark Conference session on diversity, equality and inclusion in youth ensembles, including presentations by Jim Pinchen, Surrey Music Education Hub and Barry Farrimond, National Open Youth Orchestra. In January 2018 Bridget Whyte, CEO, Music Mark facilitated a session which included a provocation by David Taylor, Director of Yorkshire Young Sinfonia, and focused on reaching a consensus response to the question 'how can we ensure the long term sustainability of Youth Orchestras/Ensembles at a local/county level?'. The ABO will continue to work with Music Mark on enabling discussion, networking and collaborative work between our respective youth ensemble members and with professional orchestras.

The Education & Youth Ensembles Consultant took part in a BBC Radio 3 Music Matters broadcast to discuss music progression.

## **FINANCE**

The ABO made a surplus for the year ended 31 March 2018 of £22,344. This resulted in the reserves increasing to £190,173.

The ABO Trust was a beneficiary of a legacy from the estate of Mrs Elizabeth Ashton Edwards in 2010. The trustees have agreed to make a grant to the ABO towards the costs of its Education & Youth Ensembles and Find Your Way programmes. The ABO Trust received a donation of £200,000 in 2016 from Diana Ambache to support the costs of the Sirens fund, to encourage the programming of works by historical women composers for a 10 year period.

## **MEMBERSHIP**

This year saw a number of new members: 12 Ensemble as Full Members; Multi-Story as Associate Members; Stagecast as Corporate Members; National Open Youth Orchestra, Digital Orchestra (Drake Music), Arabian Youth Orchestra and Highgate School as Youth Ensemble Members; and Katherine Zeserson and Anna Rowe as Sole Trader members. A full membership list is included in this Annual Review.

## GOVERNANCE

The Board met five times during the year, ensuring scrutiny of the Association's activities and finances.

Following the retirement of Andrew Connolly (BBC Concert Orchestra), Michael Eakin (Liverpool Philharmonic), Peter Helps (Sinfonia Viva) and Kathryn McDowell (London Symphony Orchestra), there were four vacancies on the ABO board and the following were elected at the AGM: Phil Boughton (Opera North), Gavin Reid (Scottish Chamber Orchestra), Helen Sprott (Philharmonia Orchestra) and Simon Webb (BBC Philharmonic Orchestra). Gavin Reid was subsequently elected Chair of the ABO by the board.

Carol Main MBE of Live Music Now Scotland completed her 6 year term as a co-opted member of the board in November, and Sophie Lewis of Sinfonia Cymru resigned in February following her appointment as Managing Director of the National Children's Orchestras of Great Britain.

The ABO is very grateful to Laurie Watt, former Senior Counsel at Charles Russell Speechlys, for his support as the Association's Honorary Legal Adviser, particularly for the use of meeting space.
